## Counseling Program

Licensed counselors and social workers who provide trauma-specific interventions including person-centered therapy, complex grief counseling, Cognitive Behavioral Therapy, Cognitive Processing Therapy, Eye Movement Desensitization and Reprocessing, and Hypnotherapy.

## Community Engagement

Special events, education, awareness, and trainings are provided to the community. Upon request, Crime Victim Center will provide outreach to schools, police departments, court personnel, and other agencies. Training topics include agency assistance, victims' rights, effects of trauma, and working with victims.

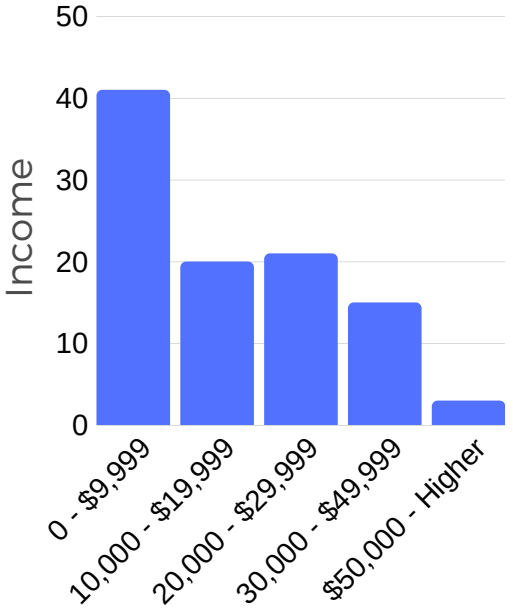
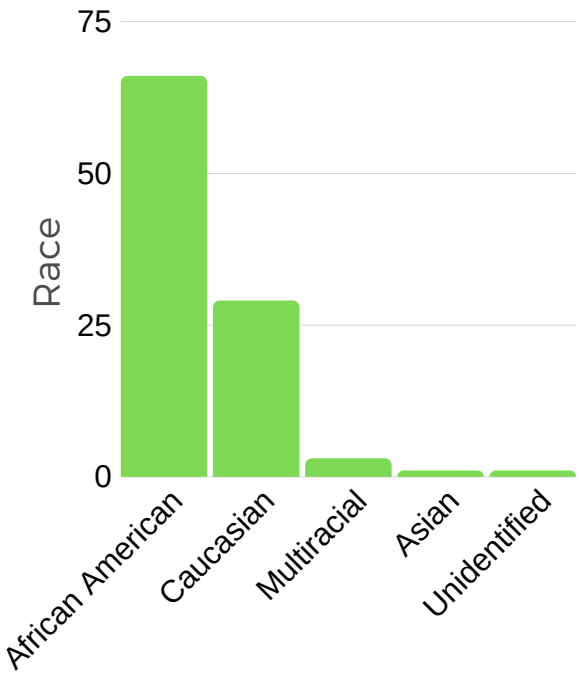
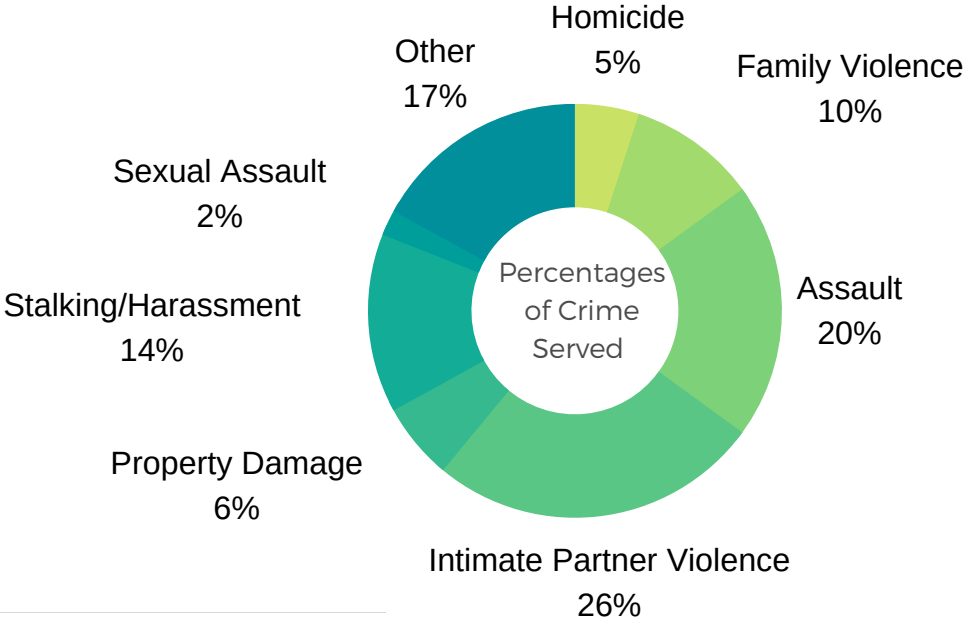
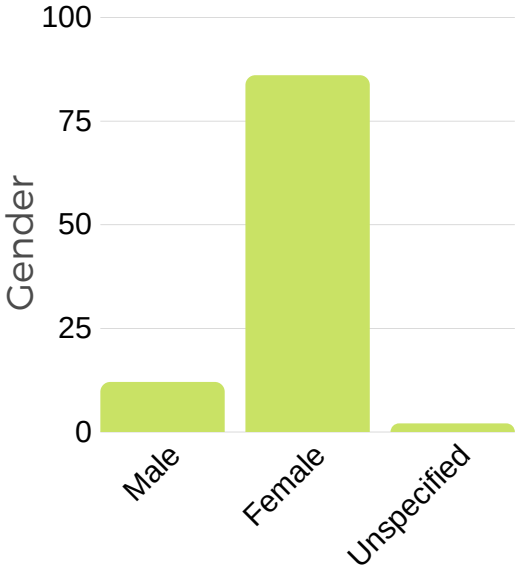
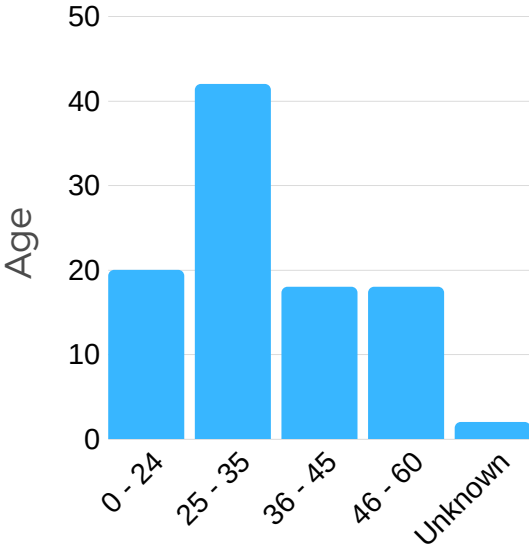
## Victim Advocacy Programs

Programs that provide crisis intervention, case management, assistance with filing court orders, help with Missouri Victims' Compensation, education on the civil/criminal justice program, and referrals. Our satellite offices within the St. Louis City and County police departments and courthouses assist victims of intimate partner violence, homicide, nonfatal gun violence, and families in crisis.

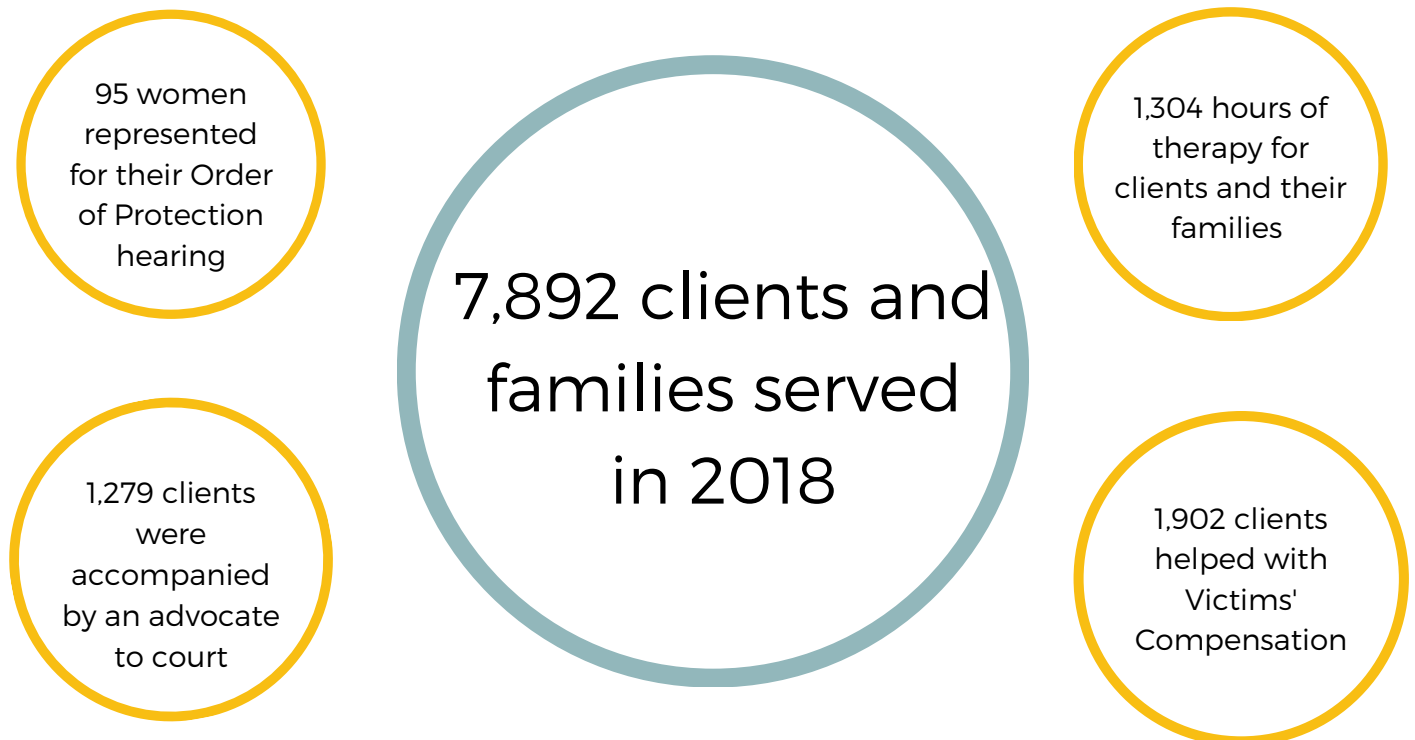
## Legal Assistance Program

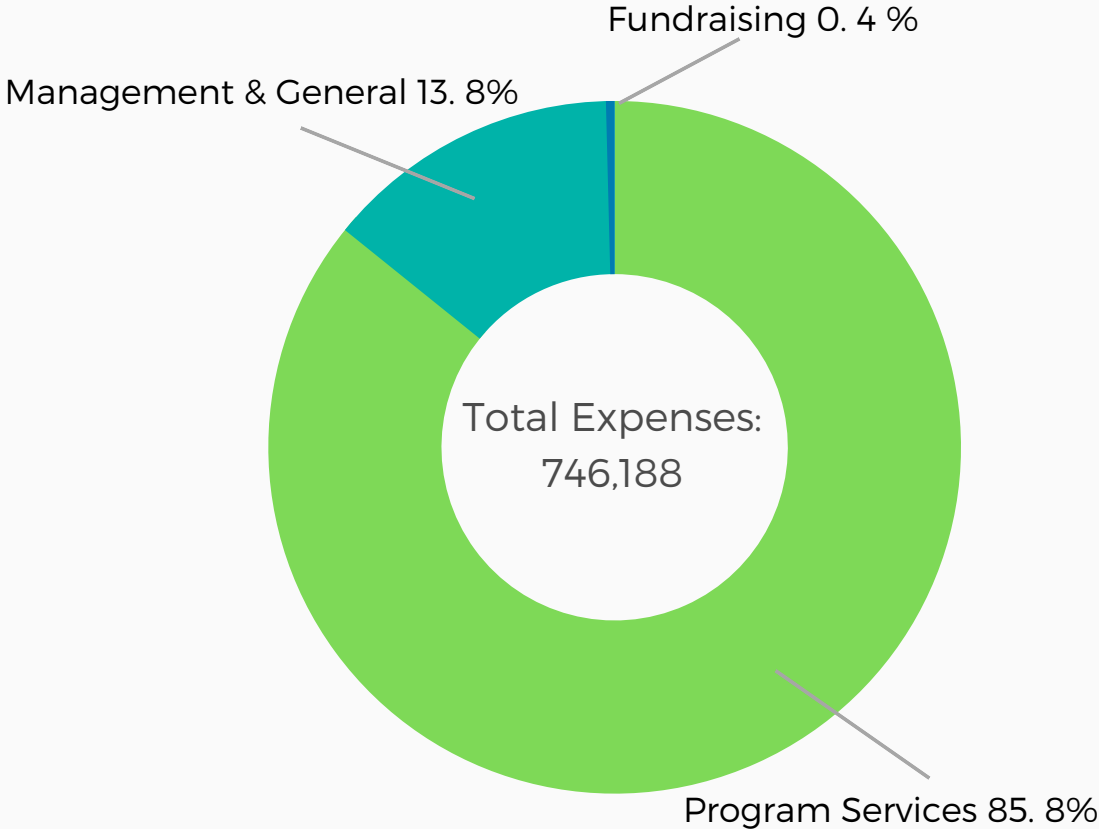
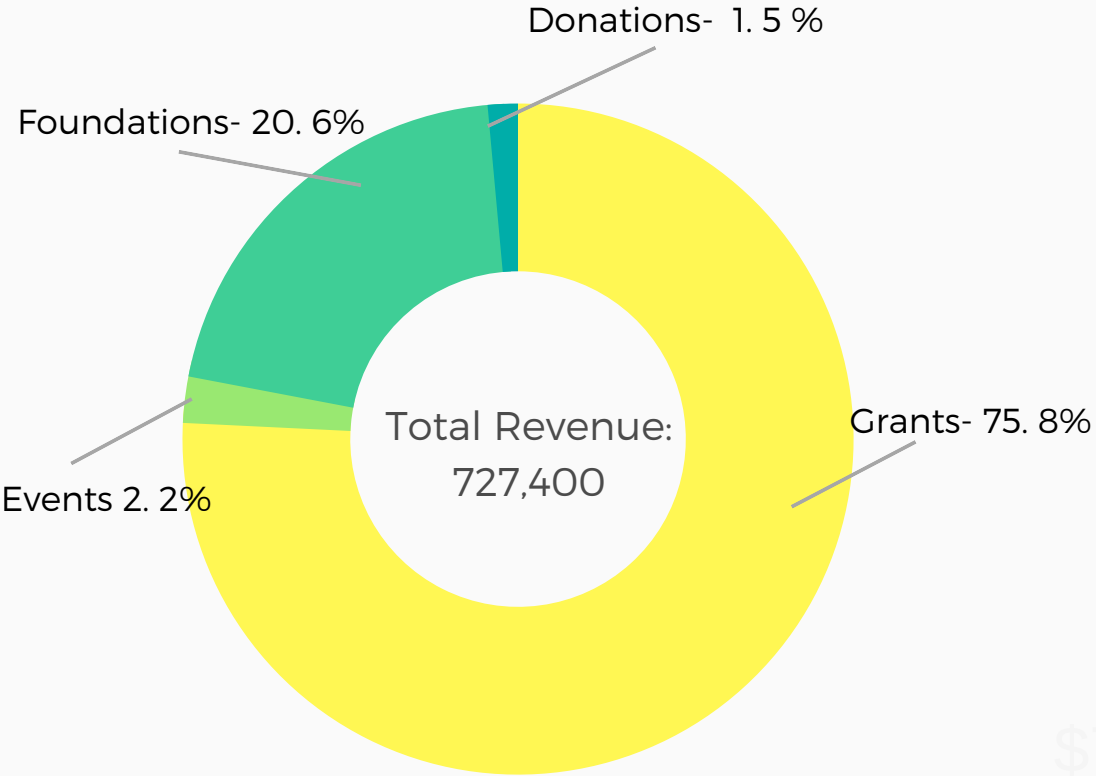
# Who We Serve



James, was experiencing trauma reactions from being caught and injured in the cross fire of gunplay while he was driving home. The streets he used to take home became a trigger for him, so he and the counselor worked on processing the memories of the trauma. James also had to learn how to handle questions from friends and family, wondering what he was doing in his life to be the target of a shooting. The counselor and James worked on the nature of victim-blaming and coping strategies regarding what to say. James also had issues with survivor's guilt, since some people were killed in the shooting. In addition to counseling, an advocate assisted James with filing for Victims' Compensation for medical bills and lost wages, since James was employed at the time of the crime.



Kenya was in a violent relationship with her children's father, Chaz for 3 years. Chaz had been arrested for threatening to kill Kenya with a gun and for hitting her with a steel chair that resulted in breaking her arm while she was holding their infant child. Crime Victim Center's domestic violence advocate in the police department contacted Kenya. Kenya was being evicted from her home and needed assistance with getting a storage unit for her household items. The advocate met Kenya at a local storage facility and the agency provided emergency funding for her to sign up for the storage unit. Kenya also filed an Order of Protection and CVC's courthouse advocate assisted her and she was able to obtain a full Order of Protection. During the Order of Protection process, Kenya mentioned that she had found a gun in her house. The victim advocate let the Detective know and they sent a police officer to seize the firearm. Chaz pled guilty to the charges and was ordered to probation. Since being in contact with our agency, Kenya has been able to find a new safe living space for herself and her children.
